Steven S. Reed is the managing member of the Louisville, Kentucky law firm of Reed Wicker, PLLC. He is serving his 12th year as a member of the Board of Trustees of the University of Kentucky, where he graduated from the College of Law, and served as board chair from 2002-2004. Steve is a native of Hart County, Kentucky and a graduate of Western Kentucky University. He served as Law Clerk to U.S. District Judge Edward H. Johnstone and as an Assistant U.S. Attorney for the Western District of Kentucky, before being appointed as Deputy General Counsel to Governor Breton C. Jones. Following his service in the Governor's office, Steve returned to the U.S. Attorney's office, where he was appointed by President Clinton to be the chief federal prosecutor for the U.S. Department of Justice in the Western District of Kentucky. Steve later was a partner at the Louisville law firm of Wyatt, Tarrant & Combs, before founding his own law firm in 2003.

After his appointment to the UK Board by Governor Jones, Steve served as a member of the executive committee, the human resources committee, and the university relations committee.

He was vice-chair of the board prior to his election as board chair.

He also serves as a member of the Prichard Committee for Academic Excellence, the Judicial Conference of the U.S. Court of Appeals for the Sixth Circuit, the Louisville Free Public Library Foundation Board of Directors, and the Kentucky Golf Association. He and his wife Nicki have three sons who are active golfers.

This Week's Speaker...

The speaker for the day was David V. Hawpe with the Courier-Journal, who spoke about the partisan divide in the state today that stands in the way of Kentucky advancing and being a better place to live. The ambition for a better Kentucky is not partisan, but politics is partisan. He cannot understand the refusal of the leaders of both parties to set aside these differences. The problem is that neither side will admit to the state being under-funded. A.B. "Happy" Chandler was a good example of a governor who saw the need to make the state better by raising taxes, as did Bert Combs who initiated the sales tax. Louie Nunn also saw the need for additional revenue and raised the sales tax and literally brought lawmakers to their knees to achieve his goals. Nunn led against the tide of "no new taxes" and he expanded services. We need someone today who will lead by doing what is right. The Fletcher administration has done good things like take on the coal operators by cracking down on over-weight trucks and Medicaid reform, but has made serious mistakes when it came to the merit system scandal and the refusal to face up to the revenue shortfall issue. The Democrats need to put up a credible alternative. He is not optimistic about this session of the legislature except in the area of coal mine health and safety.

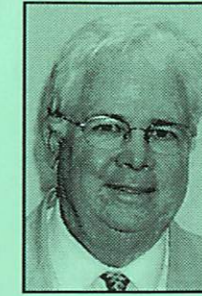

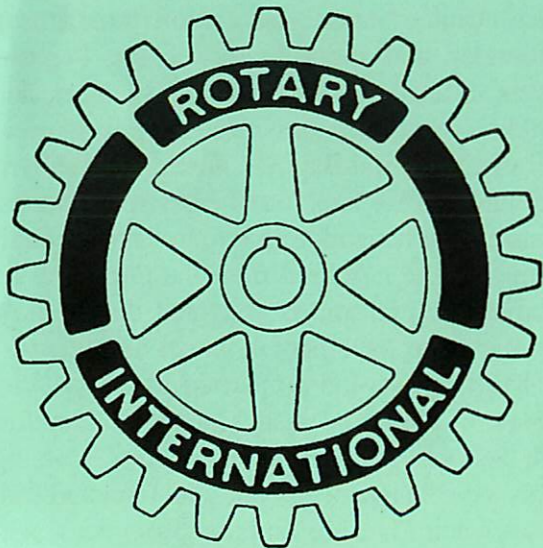

Senator Dan Kelly has served in the State Senate since being elected in 1990. He has served in leadership roles as Minority Floor Leader from 1994-1999 and as Majority Floor Leader since the Republicans gained the majority in 2000.

Because of his outstanding leadership on education issues, he received the Teacher Leader Award for his Early Literacy Intervention Program in 2002. In 2005 he received the "Outstanding Mental Health Legislator" award, received the 2005 Outstanding State Senator from NAMI Kentucky. In 2005 he received the Kentucky Association of the Deaf "The President's Outstanding Award" in appreciation for service to the deaf community. On October 6, 2005 he received a Friend of Kentucky Cities Award at the Kentucky League of Cities Annual Convention. He also received the MESA (Mathematics Education Service & Achievement) Award in November 2005.

Senator Kelly was born on August 29, 1950, in Lebanon, Kentucky. He graduated from Texas A&M University in 1973 and earned his law degree from the University of Louisville in 1979 and graduated from the Army Commander General Staff College in 1982. Senator Kelly

served as an Armor Officer in the U.S. Army on active duty from 1973 to 1978, and in the U.S. Army Reserve from 1978 to 1996. His present rank is Lt. Colonel. He is a practicing attorney in Springfield where he lives with his wife Darlene. They have five children and four grandchildren. Senator Kelly is the son of Frankfort Rotarian Col. Arthur Kelly

Senator Kelly represents the 14th District of Marion, Mercer, Nelson, Taylor, and Washington counties.

This Week's Speaker...

The speaker for the day was Steven Reed, a member and past chair of the University of Kentucky Board of Trustees. He noted that graduation rates in other states are much higher than Kentucky, specifically in Georgia and North Carolina, which goes along with their higher standards of living. Their standards are rising while Kentucky's standard of living is actually

dropping. The truth is that Kentuckians would not tolerate a poor basketball team but yet we tolerate poor academic performance. We must demand more from academic institutions in this state. He pointed to the Bucks for Brains program, which was supposed to help the University of Kentucky achieve a top twenty institution status by the year 2020. However, since the Bucks for Brains project was initiated in 1997, the community colleges have been removed from UK and we are not even at the halfway point of meeting our goal. The consequence of failure is to perpetuate the negative image of Kentucky, made even worse if we fail. UK's 60% graduation rate pales in comparison to the 80% boasted by the University of North Carolina. However, we must follow the lead of other states, which are progressing, and we must have the same will in academics we have traditionally had in basketball. Kentucky must have a fighting spirit and never give up and must not look at ourselves through stereotypes in order to move the state where it should be.

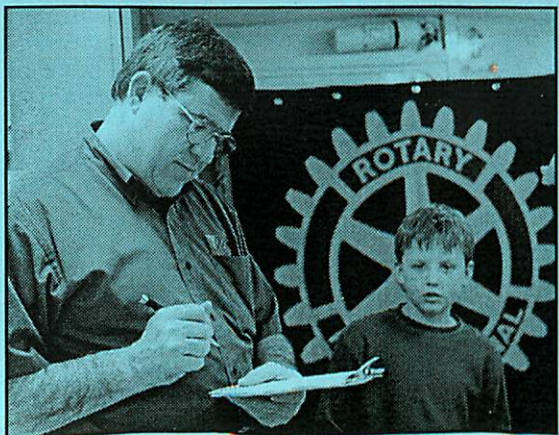

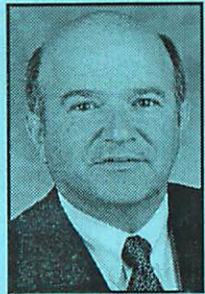

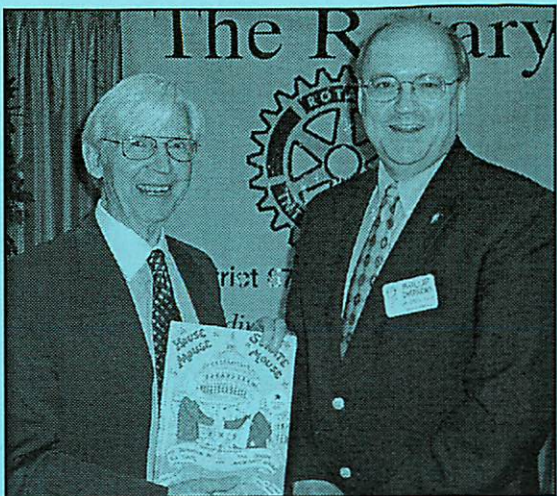

From DG Hugh McShane

We have a BIG Problem. Money to support community projects, Ambassadorial Scholars, Peace Scholar, GSE expenses and matching club grants come to us from combined District contributions to the Rotary Annual Programs Fund 3, 4 and 5 years ago. Under the formula for returning funds, 50% of all giving in any year is returned to the District in 3 years.

Our District has received more than \$500,000 in the past 2½ years through this sharing formula. However this year, giving has totaled only \$47,117 or \$13.65 per club member. This means that only \$23,000 will come back to the District in 3 years as our Share of the Annual Programs Fund. That amount won't even pay for ONE Ambassadorial Scholar.

Next Week's Program...

U.S. District Judge Karen K. Caldwell was born in Stanford, Kentucky, and graduated from Transylvania University (B.A., 1977) and the University of Kentucky College of Law (J.D., 1980). Judge Caldwell attended the University of Edinburgh Law School on a scholarship from the English-Speaking Union.

Prior to her appointment as U.S. District Judge for the Eastern District of Kentucky by President George W. Bush in 2001, Judge Caldwell was a partner in the Lexington, Kentucky office of the law firm of Dinsmore & Shohl, LLP, specializing in complex litigation, commercial law, and criminal defense law.

Judge Caldwell was designated by the Kentucky Bar Association as the "Outstanding Lawyer in Kentucky" in 1995. She was appointed by President George H.W. Bush to serve as United States Attorney for the Eastern District of Kentucky, where she served as the U.S. Justice Department's top lawyer in the eastern half of the state from 1991-93. In that capacity, Judge Caldwell supervised the U.S. Attorney's Office, and all civil cases and criminal prosecutions in the eastern half of Kentucky. Judge Caldwell was assigned to the Frankfort Division of the U.S.

District Court last year, and she presides over all civil and criminal cases in the federal district court from Anderson, Carroll, Franklin, Henry, Owen, Shelby and Trimble Counties.

Judge Caldwell is married to Lloyd Cress, who currently serves as Commissioner of the Department of Environmental Protection.

This Week's Speaker...

The speaker for the day was State Treasurer Jonathan Miller, who stated that the thing that stands at the core of all religions and cultures is compassion for others. This includes the poor, young and elderly. He spoke about the Biblical admonition to love our neighbor as ourselves and how we need to adhere to the Golden Rule. This applies to taking care of military families, who exemplify the ultimate compassion often by making the ultimate sacrifice. Regardless of how we feel about this war, we all support the troops. He stated that military families are struggling today.

Half of the troops in Iraq have been mobilized from the National Guard and Reserves and, unfortunately, are often forced into poverty and are the victims of cruel scams. This is why Jonathan has proposed the Military Family Bill of Rights, which consists of two parts. The first is legislative, where he is supporting several bills in the General Assembly to provide a safety net for families to protect them from predatory schemes. The bill also include a military assistance fund and a bill to reward patriotic employers through tax incentives who, for example, help supplement the income of the serviceman. The second part of the Bill of Rights involves education. Unfortunately, there is much financial illiteracy, and high schools are all starting financial literacy courses to combat this problem. He implored Rotarians to help out here by serving with compassion and interest in helping military families. While veterans have signed up to help, we can all help in our various professions toward aiding military families with simple matters such as balancing a checkbook. Jonathan states that this is the embodiment of family values which is all consistent with the Golden Rule.
