David Simcox is a former career Foreign Service officer of the State Department. In his 30-year diplomatic career he served at US diplomatic posts in Mexico, Panama, Brazil, Dominican Republic, Ghana and Spain, specializing in political, labor, population and migration issues. After leaving the State Department in 1986, Dave was for seven vears executive director of the Center for Immigration Studies in Washington, DC, a nonprofit public-interest think tank that studies the fiscal, demographic and labor market effects of rising immigration into the US. From 1998 to 2004 he was Chairman of the Center's policy board. He has written extensively and testified frequently in Congress on immigration policy issues and relations with Mexico. Dave now resides in Louisville. He is a native of Frankfort, Kentucky, and a graduate of UK. He holds graduate degrees from American University and the National War College, both in Washington, DC. He is a Marine Corps veteran of the Korean Conflict.

This Week's Speaker...

The speaker for the day was Lexington Herald columnist and blogger Larry Dale Keeling, who stated that he has the best job in journalism, which is to be an "opinionated SOB". He is willing to take criticism as well as to dish it out. He then opened up the floor to questions as follows: (1) Concerning the politics of mountaintop removal he opined that this is a destructive way to remove coal but that big industry usually gets what it wants as do developers. (2) Concerning this November's elections, he stated that the Democrats should pick up some seats on the national level although he would not predict they would take back either house of Congress. On the state level, the Republicans would probably have done better were it not for the Fletcher scandal but he expects a continuation of the status quo in the House and Senate. (3) The Republicans will probably put up a candidate against Fletcher,

which may be Billy Harper of Paducah. Harper would probably not have made this announcement had it not been cleared with McConnell. Secretary of State Trey Grayson may be a running mate. (4) The Governor thinks that the criminal charges against him will be dismissed but we will soon find out. (5) Ben Chandler may run for Governor to follow in the footsteps of the grandfather but is happy in the House. Much depends on the results of the November elections. Other candidates who may run are Jerry Abramson and Crit Luallen, but they will not run against each other. Steve Henry would run if he could find a running mate. (6) He opined that more politicians are not going to Fancy Farm because of Fletcher's problems. Fletcher does not want to get heckled. (7) As to whether Fletcher's problems are caused by the liberal media, he described himself as an Eisenhower conservative but because the Republican Party is no longer the party of limited government, fiscal restraint, and noninterference with people's private lives, the Party left him. Fletcher's problems are caused by arrogance and the fact that he did not listen to Republican lawmakers who made offers to help. His problems are of his own making. (8) On the subject of Constitutional reform, the 115-year-old state Constitution does not serve us well and there are too many constitutional officers. While we need an independent and elective Attorney General and Auditor, the other offices should be appointed. However, he sees no movement toward reform at this time. (9) On the subject of blogging, he stated that blogs are a part of the media's future and that all the media will be taking advantage of the Internet. (10) As to Congressional races, Barlow does not have much of a chance, but Weaver and Lucas are doing well. (11) As to the future of gambling in the state, it does not have a chance unless there is governor who gets in back of it.



# This Week's Speaker...

The speaker for the day was retired Foreign Service Officer David Simcox, who spoke about the worldwide problem of both legal and illegal immigration. This epidemic is global due to worldwide mobility and the growth of the labor force. This has caused great migration to the industrialized West. Nearly 2.2 billion people are in the labor force in the third world, which has an unemployment rate of 40%. There is an intense pressure to search for jobs in the West.

United States is the largest host nation, with one in six people in the United States having been born elsewhere. Due to the economic boom in the United States in the late 1990s, there has been a tremendous influx of migrant workers. We are the "mother of exiles" with approximately 1.5 million immigrants coming to this country annually. 600,000 of this number are illegal. One-half of these immigrants are of Latin origin with the next largest number coming from Asia. 30% of the legal and illegal immigrants come from Mexico. While most formerly settled in the gateway states, immigrants are increasingly spread out across the nation. There is widespread resentment, because immigrants fill generally low-paying jobs but have a high need for social programs. Many are related to someone already here, with one-half of those who originally entered illegally ending up with green cards. Most who come as the result of family reunifications are legal. It was not until the 1970s that Congress considered legislation to penalize employers who hire illegal immigrants and in 1986 Congress provided for such penalties but without strict enforcement. Also in 1986, there was a blanket amnesty given to these immigrants, but the result has been to create widespread skepticism about future amnesty programs. However in Congress there is much opposition to a national identification card, and there have been moves to deny access to social programs. No administration has really wanted to face up to the problem of illegal immigration but this changed after 9/11. Businesses, employers, academic leaders and farmers want easy immigration while states and those concerned about potential terrorism want more restrictions. While border controls are not popular with many groups and the sending countries like Mexico, security needs must be addressed. The Immigration Control Act was passed by the Senate. The Act contains a guest worker program, but the House version is much more restrictive with an "enforcement first" approach. The House version concentrates on border control and has no guest worker provision. Polls show that the majority of

There are 200 million migrants worldwide. The

Americans want lower immigration. It is impossible to reconcile the House and Senate versions addressing the problem of immigration. Mr. Simcox predicts that there will not be final action until the 2007 Congress. In the meantime, states are forced to legislate their own border controls.

This Week's Speaker...

Ed Hatchett, Jr.

The speaker for the day was KET Executive Director Mac Wall, who spoke about "megatrends" and how they translate to digital TV. Referring to globalism and changing demographics and values, he spoke about the vast changes in the world today and how these relate to changes in public television. One astounding sign of change is that more income tax returns are prepared in India than in the United States, and 300 million Chinese are now fluent in English. The average life span by the end of this century will be 107. KET is keeping pace with all these global changes, since this is a different kind of world today than it was just fifty years ago. He gave the Club several questions testing their TV IQ about shows in the fifties. For example, President Carol knew that The Ed Sullivan Show was originally called "The Toast of the Town." Edward R. Murrrow pioneered the one-on-one television interview, and because of Murrow's cigarette smoke, the close-up was invented since Murrow could not be seen through the smoke! As demonstrated by his TV quiz, Mac showed that

All older members of the Club remember television test patterns, which were a still signal used to focus and set up cameras. In 1959, Bonanza was the first color television show, because of its rich primary colors. RCA owned NBC and RCA sold television sets. When the repairman would come, the RCA logo would be on the side of the box. The second color show was Walt Disney's Wonderful World of Color. TV sales shot up. The High Definition (HDTV) digital sets today are following this same track. On February 17, 2009, all analog signals will be gone as we make the transition to digital TV. 85% of the public is now on cable or satellite. To show how times have changed, Mac stated that college freshmen today do not know what a typewriter is, or an 8-track tape. They know only cable TV and do not know what carbon paper is. They have never heard of Johnny Carson and only know microwave popcorn. He showed an example of the transition to digital TV and said that today there are a great variety of shows on KET including the arts and public affairs programs. KET is Kentucky's network, covering all types of stories including health education. Today, six KET channels can be received simultaneously with standard definition services originating from one location. The shows can be downloaded on iPods. KET is committed to health and wellness issues. A new feature on KET is "encyclomedia," which is research based and provides learning without limits. For example, students no longer have to "power down" in the classrooms since state of the art technology is now available there also. KET belongs to the people of the Commonwealth, and frequently airs interesting documentaries about Kentuckians. Mac ended his talk by stating that KET is "about Kentucky."



This Week's Speaker...

Speaker of the House and fellow Rotarian Jody Richards spoke about changes in Kentucky and Frankfort since he first served in the House of Representatives in 1976. He also reviewed recently-enacted state legislation. Speaker Richards remarked on how Frankfort

is an historic and beautiful city that has progressed in the last 31 years. He noted that work toward the History Center began right after he became Speaker, and he recalled conversations with Dr. Thomas Clark who worked hard for its creation. He said that KY has also shown progress and enjoys high national rankings on various economic indicators. He said that the General Assembly has changed greatly since 1976, when the Governor instructed members on how to vote each day. We now have three co-equal branches of state government; and legislators have developed expertise in various policy areas. He said that it's important for the House and Senate, both political parties, and the General Assembly and the Governor to work together well, which he feels did happen last session. Among recent legislation Speaker Richards lauded were bills regulating sex offenders, strengthening ATV and graduated drivers licensing rules, providing tax incentives for ethanol production and coal liquefaction, limiting eminent domain use, assisting small businesses with employee health coverage, providing legal rights to grandparents who are primary caregivers for their grandchildren, and changing the alternative minimum tax. Speaker Richards also reviewed recent state budget provisions, especially those affecting education, which he described as the most important function of KY state government.



Next Week's Program...



Jim Host recently served as Secretary of Commerce for the Commonwealth of Kentucky under Governor Ernie Fletcher for approximately 2 years, retiring in October 2005. He also was formerly chairman and CEO of Host Communications.

Inc. (HOST), which he founded in Lexington, Kentucky in 1972. HOST became a subsidiary of Bull Run Corporation (NASDAQ: Bull) in December 1999, and he stepped down as CEO in 2001.

Host, a UK graduate, played pro baseball after receiving one of UK's first baseball scholarships, worked with P & G in sales and spent the 60's with his own real estate, building and insurance companies, as well as doing play-by-play work for several networks involved with UK sports.

At age 29, he became the youngest member of Kentucky Governor Louie B. Nunn's Cabinet as commissioner of the Department of Public Information and then commissioner of the Department of Parks. He was the Republican Party nominee for Lt. Governor in 1971, but lost in the General Election.

Host returned to Lexington in 1972 and opened Jim Host & Associates, which subsequently began rapid development in 1974 with two contracts, a basketball and football radio agreement with the University of Kentucky and an executive management relationship with the National Tour Association. He began a 27-year business relationship with the NCAA in 1975.

Host personally is credited with implementing the first collegiate corporate marketing program with the National Collegiate Athletic Association in 1985.

In 2000 he was named to the University of Kentucky Distinguished Alumni Hall of Honors and the state of Kentucky's Athletics Hall of Fame. In 2001 he received one of Kentucky's top civic awards, Kentuckian of the Year by the Chandler Foundation. In 2003 he received the Lifetime Achievement Award from the University of Kentucky School of Journalism and Telecommunications. In 2004, he received the Rural Kentuckian of the Year Award given by the Rural Electric Co-ops of Kentucky.

He received a lifetime achievement award from the National Association of Collegiate Marketers and has been inducted into the Travel Industry of America's Hall of Leaders and the National Tourism Foundation Hall of Fame.

He currently is a member of the Executive Committee of the International Basketball Hall of Fame, and is serving as Chairman of the Louisville Arena Authority.

He is also the Chairman of the World Equestrian Games, which will be coming to Kentucky in 2010.


